OFFICIAL RULES

- SWEEPSTAKES PERIOD:** The Sweepstakes begins on July 1, 2021 at 12:00 PM Eastern Time (“ET”) and ends on September 7, 2021 at 11:59:59 PM ET (“Sweepstakes Period”) and includes nine (9) entry periods (each an “Entry Period”) as outlined in the chart below:

Non-winning entries will carry forward into subsequent Entry Period drawings. The Administrator’s computer is the Sweepstakes official clock.

- ELIGIBILITY:** The Sweepstakes is offered only to legal residents of the fifty (50) United States (excluding Utah) and the District of Columbia who are at least twenty-one (21) years of age at the time of entry (“Entrant”). Employees, officers, directors, representatives, and agents of Sponsor,

Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities"), and each of their immediate family members (e.g., spouse, parent, sibling, child, and their respective spouses and the "steps" of each, all lineal descendants, including those by adoption, regardless of where they reside) and persons living in the same household of each, whether or not related, state alcoholic beverage manufacturers, distributors, and retailers and employees of state or local alcohol beverage agencies are not eligible to enter or win. This Sweepstakes is void in Utah, Puerto Rico, all other United States territories and possessions, and where prohibited or restricted by law. All federal, state, and local laws apply.

Participation constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. Winning a Prize is contingent upon fulfilling all requirements set forth herein. If an Entrant participates via a mobile device, message and data rates may apply. Not all cellular phone providers carry the service necessary to participate in this Sweepstakes through a mobile device. If entering using a mobile device, please check your mobile device's capabilities for specific web enabled browsing instructions and pricing plans. All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. For purposes of the Sweepstakes, an Entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical addresses or e-mail addresses.

2. HOW TO ENTER THE SWEEPSTAKES: Make a Purchase: There are two (2) ways to enter the Sweepstakes:

A. Make A Purchase: During the Sweepstakes Period, an eligible entrant who is not a California resident may purchase any bottle of 19 Matua wine at any participating store, ("Qualifying Purchase"), while supplies last. Entrant must then visit matuasummer.com ("Website") and complete and submit the registration form, including, but not limited to: his/her first and complete last name (no initials), phone number, city, state, and agreement to these Official Rules. The entrant must then follow the on-screen prompts and upload a photograph of the original receipt showing the Qualifying Purchase. It is recommended that purchaser first print his/her name on the original register receipt; sign and date the receipt; and circle the qualifying product on the receipt before uploading the receipt. An Entrant who is a resident of California may not enter the Sweepstakes by making a Qualifying Purchase and uploading a receipt at the Website. If a resident of California uploads a receipt at the Website, he/she will not receive an entry. A resident of California may instead take a photo of the Qualifying Purchase product and upload the photo at the Website. The file must be in .JPEG, .JPG, .PNG, or .GIF format (no PDFs will be accepted) and may not exceed 8 MB. Receipts must be submitted by 11:59:59 PM ET on August 31, 2021 to be valid. It is strongly recommended that the entrant maintain possession of the original or photocopy. The entrant should not give a receipt to any store employee. Upon verification, an Entrant will receive five (5) Sweepstakes entries into the applicable Entry Period for each Qualifying Purchase on an uploaded receipt (or, for a resident of California, five [5] Sweepstakes entries for each Qualifying Purchase product in an uploaded photo). An Entrant may include multiple Qualifying Purchases (or multiple pictured Qualifying Purchase products for California residents) on a single receipt/photo (each Qualifying Purchase should be circled separately), but a Qualifying Purchase and receipt/photo may each only be used once. An Entrant should keep all original receipts/photos submitted, as Sponsor may request Entrant provide an original receipt/photo for verification. Note: Qualifying Purchase and receipt upload (or photo upload) entries will not be included in an Entrant's number of entries/Prize Tier display at the Website until verified. Limit: an Entrant may upload five (5) receipts/photos total and earn five (5) entries. Digital receipts will not be accepted. Duplicated receipts will not be accepted. Receipts must be

readable. Mechanical reproductions, altered receipts or unreadable receipts will not be accepted. Receipts submitted in excess of the limits set forth herein will not be accepted.

Watch A Video For Additional Sweepstakes Entries: During the Sweepstakes Period, an entrant may obtain up to five (5) additional entries by following the instructions on the Website to watch a video. Entrant will receive five (5) entries into the applicable Entry Period for watching the video. Limit: Entrant may watch the video one (1) time and receive five (5) bonus entries.

Share On Social For Additional Sweepstakes Entries: During the Sweepstakes Period, an entrant may obtain up to ten (10) additional entries by following the instructions on the Website and set forth below to share the Sweepstakes on Facebook or Twitter. Upon clicking the buttons to share the Sweepstakes, a message with a unique link will be posted to the entrant's choice of his/her Facebook Wall or Twitter Feed ("Invitation Post"). To obtain additional entries, an entrant's Facebook "Friend" or Twitter "Follower" must click on the unique link in the Invitation Post and complete and submit the registration information requested, and enter the Sweepstakes. Upon the Friend's or Follower's successful entry into the Sweepstakes, the original entrant will receive one (1) entry into the Sweepstakes. An entrant will receive one (1) entry for each Friend or Follower who enters the Sweepstakes by following the unique link in his/her Invitation Post, up to five (5) entries via Facebook and five (5) entries via Twitter for a maximum of ten (10) additional entries.

NOTE: During the Sweepstakes Period, an entrant may receive a link to the Website by scanning the QR code on select Sweepstakes print advertising. An entrant may center the QR code in the camera and scan the QR code. Once completed, the entrant will receive a link to the Website, and may follow the steps noted above to participate in the Sweepstakes. **An entrant cannot participate solely by scanning the QR code.**

B. Mail-In Without Making a Purchase: To earn a Sweepstakes entry without making a purchase, an entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. A Mail-In Entry is worth twenty (20) entries. An entrant may mail-in one (1) time during the Sweepstakes Period. Following this method of entry, an entrant will receive twenty (20) entries into the applicable Entry Period.

All Mail-In Entries must be postmarked by and received by the respective dates indicated in the chart above in Section 1. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, and Mail-In Entries sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

Limit: Regardless of method of entry, an entrant will receive no more than twenty (20) total entries during the Sweepstakes Period. If more than the stated number of entries are received from the same person, telephone number and/or e-mail address, the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor's sole discretion, may be disqualified and not be eligible to win a prize. RANDOM DRAWING: On or around each drawing date indicated in the chart above in Section 1, the Administrator will randomly select one (1) potential grand prize winners, one (1) potential first prize winner, one (1) potential second prize winner, two (2) potential third prize winners, one (1) potential fourth prize winner, and one (1) potential fifth prize winner from among all eligible entries received for each Entry Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

4. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

A. Grand Prizes (9 total; 1 per Entry Period): Each grand prize is \$1,000 (each a "Grand Prize"). No more than nine (9) total Grand Prizes will be awarded, one (1) per Entry Period, will be available in the Sweepstakes. The ARV of each Grand Prize is \$1,000.

B. First Prizes (9 total; 1 per Entry Period): Each first prize is an Eola Bucket Cooler Bag (each a "First Prize"). No more than nine (9) First Prizes, one (1) per Entry Period, will be available in the Sweepstakes. The ARV of each First Prize is \$149.95.

C. Second Prizes (9 total; 1 per Entry Period): Each second prize is a Brantley Backpack (each a "Second Prize"). No more than nine (9) Second Prizes, one (1) per Entry Period, will be available in the Sweepstakes. The ARV of each Second Prize is \$129.95.

D. Third Prizes (18 total; 2 per Entry Period): Each third prize is a 25 oz. Classic Canteen (each a "Third Prize"). No more than eighteen (18) Third Prizes, two (2) per Entry Period, will be available in the Sweepstakes. The ARV of each Third Prize is \$34.95.

E. Fourth Prizes (9 total; 1 per Entry Period): Each fourth prize is a a stemless (each a "Fourth Prize"). No more than nine (9) Fourth Prizes, one (1) per Entry Period, will be available in the Sweepstakes. The ARV of each Fourth Prize is \$27.95.

F. Fifth Prizes (9 total; 1 per Entry Period): Each fifth prize is a Corkcicle Air (each a "Fifth Prize"). No more than nine (9) Fifth Prizes, one (1) per Entry Period, will be available in the Sweepstakes. The ARV of each Fifth Prize is \$25.

G. Total ARV: The total ARV of all prizes is \$12,624.30.

H. Odds of Winning: The odds of winning a prize depend on the number of eligible Sweepstakes entries received for each Entry Period during the Sweepstakes Period.

I. General Conditions: There is a limit of one (1) prize per person. In no event will more than nine (9) Grand Prizes, nine (9) First Prizes, nine (9) Second Prizes, eighteen (18) Third Prizes, nine (9) Fourth Prizes, and nine (9) Fifth Prizes, be awarded. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
